



**CALIFORNIA AMATEUR HOCKEY ASSOCIATION**  
**Instructions and Application for New or Renewal of Associate Membership: 2016-2017**

**New Members:**

1. New requests for membership must still be submitted by completing, signing, scanning and emailing the attached application for new membership. **New memberships cannot be processed online.**
2. A check for \$50 must accompany all requests for new membership.

**Membership Renewals:**

1. Annual renewals and team fees must be paid prior to September 30th of each year.
2. Membership renewals can be processed in two ways:
  - Online: Members can renew via the online link on the Member Services tab on the CAHA website, and pay via PayPal.
  - Mail: Members may complete the attached application, scan and email it, and mail a check to:

**Fees (2016-2017 Season):**

The annual membership fee is \$50 for new membership applications and \$20 for annual membership renewals, plus an amount equal to \$30 per A or B youth team (Boys, Girls, or Co-ed) registered by a club, and \$50 per High School\*, Tier I and Tier II team (Boys, Girls, or Co-ed) registered by a club during the current season. If teams are added after the date that the membership application is submitted, the Member Association will remit the additional fees directly to CAHA Member Services. There is no fee per team for adult, adult women, college, or in-house teams (only the new member fee of \$50, or the renewal fee of \$20). Sled hockey teams do not pay a fee to CAHA but must be registered with USA Hockey with a CAHA number in good standing.

*\*Note: Fees for High School teams rostered in an independent high school league will be paid by the league (i.e. Ducks, Sharks, Kings leagues); the exception will be pure high school or prep school teams competing in a pure league out of the geographic area – in these instances the pure team is rostered by the closest league registrar (North or South) under an identified high school CAHA number. The team itself does not become an independent member of CAHA.*

**FREQUENTLY ASKED QUESTIONS**

**CAHA Association Number:**

A CAHA Association Number (CAH xxxx) is assigned by USA Hockey when an Association is accepted as a CAHA member. That membership number must then be renewed each succeeding year by filing a CAHA membership renewal form with the CAHA Director of Member Services by September 15th to remain active. A separate form is required for each Association number even if the contact information is the same for several member associations controlled by the same organization (such as when additional Cybersport numbers are requested, see below).

**Supporting Documentation:**

The documentation that must accompany this form depends on whether the Association is controlled by a for-profit or not-for-profit organization. For-profit organizations (e.g., commercial ice rinks) must submit a true copy of the business Certificate of Status from the California Secretary of State and a mission statement describing the amateur hockey programs that will register teams under this Association. Not-for-profit organizations must submit true copies of the organization's IRS 501(c) status letter, bylaws currently in place, and a list of current officers and directors and their contact information.

**Additional Requests for Cybersport Numbers:**

A CAHA member association may request additional Cybersport numbers to track their different programs. If an additional Cybersport number is needed, there will be no charge as long as the program is registered to the same master member association with the same tax ID number. However, additional Cybersport numbers must complete the appropriate section on the Application for Membership form.
